### 2017 FIDIC Awards - Call for nominations

Dear colleagues,

I have the pleasure to announce the call for entries for the 2017 FIDIC Awards. Award nominations are open to all firms or groups of firms that belong to FIDIC Member Associations, Associate Members, or Affiliates. All submissions should be endorsed by one FIDIC Member Association, Associate or Affiliate based in the country where the project is located or where the firm is based.

The awards are for projects that have been in operation for at least 1 year on the closing date for submissions and should have been completed in the last 5 years. A maximum of 25 entries will be accepted from each country.

Submitted projects must demonstrate innovation, quality, and professional excellence; the principles of transparency and integrity; and sustainability and respect for the environment.

Shortlisted firms will be encouraged to display a poster presenting their projects at the FIDIC International Infrastructure Conference in Jakarta, Indonesia (1-3 October 2017). More information about the conference in Jakarta is available at <a href="https://www.fidic2017.org">www.fidic2017.org</a>

Firms that receive an award will be recognised at a special ceremony during the FIDIC Conference Gala Dinner on Monday the 2<sup>nd</sup> of October 2017 in Indonesia.

Detailed description, eligibility, submission materials, judging, and deadlines are enclosed in the attached documents.

I look forward to receiving Award nominations from all member countries.

# **FIDIC Awards 2017**

### **Programme**

### 1. Introduction

FIDIC Awards are presented every year for projects that help world economies and communities to develop a higher Quality of Life.

The programme below outlines the aims of the FIDIC Awards, the nominations being sought, how they will be judged, and the outline programme for submission of nominations and judging of the nominees.

#### 2. Aims of the Awards

The FIDIC Awards will:

- promote FIDIC principles: Quality, Integrity and Sustainability
- celebrate outstanding projects where FIDIC member firms have had a major involvement
- help publicise the work of consulting engineering firms and the contribution they make to quality of life
- encourage others to understand and support FIDIC principles
- encourage the use of FIDIC contracts and guidelines

The Awards will support the aims of the Federation which are to promote the use of international FIDIC best practice and resources.

The FIDIC Awards will be presented at the Gala Dinner during the FIDIC International Infrastructure Conference, on **Monday 02 October 2017**. More information is available at www.fidic2017.org

### 3. Award Nominations

Award nominations are open to firms that have provided the main engineering services on projects of all types and all sizes.

The nominees should be firms or groups of firms that belong to FIDIC Member Associations & Associates, or Affiliates. All submissions should be endorsed by FIDIC Member Associations or Associates based in the country where the project is located or where the firm is based.

Nominations should demonstrate:

- innovation, quality, and professional excellence
- the principles of transparency and integrity. FIMS or other Integrity Management Systems will be considered
- sustainability and respect for the environment

Projects should have been in operation for at least 1 year on the closing date for submissions and should have been completed in the last 5 years. A maximum of 25 entries will be accepted from each country. If more than 25 entries are received from one country, priority will be given to those endorsed by the corresponding FIDIC MA over the ones presented by Associate Members, which in turn will have priority over those presented by Affiliates.

### 4. Award Prizes

The headline categories for the awards will be:

- FIDIC Outstanding Project of the Year
- FIDIC Award of Merit

The total number of prizes to be awarded will be at the judges' discretion.

### 5. Judges

The judging team is comprised of the FIDIC Past Presidents, convened by the Immediate Past President. The judges will convene and rank the projects. All projects that are judged to be of particular merit will receive a FIDIC Award.

# 7. Submission guidelines

The Award Nomination Form should be sent with:

- Signatures by the submitting firm(s) and the client(s)/owner(s) of the project.
- A letter from the FIDIC Member Association or Associate in the country where the project is located or where the firm is based endorsing the submission of each project to the FIDIC Awards.
- Up to 5 photographs of the project. The format should be JPG or JPEG in high resolution. Pictures should include only one image of the project per picture.
- A maximum of 5 pages that describe the project, the services provided by the firm, and information that demonstrates why the project should receive an award: the project's innovation, quality, and professional excellence; the principles of transparency and integrity and; sustainability and respect for the environment.

Please note that the document describing the project must not be longer than 5 pages. Only the first five pages will be evaluated.

Names and information in the form and material should be typed or printed in the English language.

Shortlisted firms will be encouraged to display a poster presenting their projects at the 2017 FIDIC International Infrastructure Conference in Jakarta, Indonesia.

The awards will be presented at the FIDIC Awards Ceremony and Gala Dinner on the 2<sup>nd</sup> of October 2017 in Jakarta, Indonesia that takes place during the FIDIC conference.
