EFCA Board meets with Macedonian association ACEMA

Against the background of an ongoing series of reforms to strengthen Macedonia's democratic institutions and to facilitate the opening of EU accession negotiations, the EFCA Board met in Skopje on 22 and 23 February 2018.

EFCA offered its support to ACEMA and Macedonia's public administrations in the roll out of the EU Public Procurement Directives to promote MEAT principles, to enhance capabilities to effectively manage complex projects, and increase transparency.

ACEMA is expected to submit its application for EFCA observer membership for approval to the 1 June 2018 General Assembly Meeting in Ghent.

EFCA participate in 4th FIDIC Regional Infrastructure Conference

EFCA President Kevin Rudden attended the 4th FIDIC Regional Infrastructure Conference in Tbilisi, Georgia on 6th & 7th March 2018. The conference coincided with the 1st Anniversary of the Association of Consulting Engineers Georgia (ACEG).

In December 2017, FIDIC unveiled a new suite of Contracts to reflect the challenges construction contracts will face in a rapidly developing and highly digitized future. These changes will ensure that FIDIC Contracts remain the contract of choice for International projects particularly in Eastern Europe, Africa, the Middle East and Asia.

The conference focused on the principal changes between the 2017 and 1999 contracts. Experts shared best practices in adapting the FIDIC forms of contracts and agreements to national requirements in the Central Eastern European and Eurasia region.



The conference was opened by Mr. Zurab Alavidze, Minister of Regional Development and Infrastructure, EFCA President Kevin Rudden, FIDIC Managing Director Enrico Vink, FIDIC Executive Committee Member Gavin English and ACEG President Daduna Kokhreidze.

The [guidance](#) recalls the main innovations, opportunities opened up by the 2016 General Data Protection Regulation (GDPR), takes stock of the preparatory work already undertaken and outlines the work still ahead of the European Commission, national data protection authorities and national administrations.

The Commission launched a new practical online tool to help citizens, businesses, in particular [SMEs](#), and other organisations to comply and benefit from the new data protection rules.

Through the [platform](#) you can search and analyse available data on public procurement at national level for 35 jurisdictions (EU member states, the EU institutions, Norway, Iceland, Switzerland, Serbia, Georgia and Armenia).

Beyond the possibility of download the databases, the portal will also include some indicators of transparency and administrative quality.

Macedonia taking steps on path to EU

Macedonia, working on settling its chronic name dispute with Greece, is one of the six Western Balkan nations seeking EU membership. The other western Balkan states are Serbia, Montenegro, Albania, Bosnia and Herzegovina, and Kosovo.

The EBRD, leading institutional investor in the six countries of the region, issued a [report](#) that is emphasising the need for intensified reforms for building sustainable market economies.

EU - Western Balkans [Strategy](#): a credible enlargement perspective

The strategy spells out the priorities and areas of joint reinforced cooperation, addressing the specific challenges the Western Balkans face.

The Western Balkans need to implement comprehensive reforms in crucial areas: strengthening the rule of law, fundamental rights and governance, and pursuing economic reforms.

The Commission proposes to gradually increase funding under the Instrument for Pre-Accession Assistance (IPA) until 2020 in so far as reallocations within the existing envelope allow. In 2018 alone, €1.07 billion of pre-accession assistance for the Western Balkans is already foreseen.

New programmes to address migrant situation and support reintegration in Africa

The EU adopted three new programmes, worth over €150 million, under the European Union Emergency Trust [Fund](#) for Africa.

The future of the European budget

The European Commission has set out [options](#) - and their financial consequences - for a new, modern, long-term EU budget in order to deliver efficiently on the priorities for Europeans beyond 2020.

Roadmap to put the EU economy on a more sustainable path

Sustainable finance experts presented the Commission with new [recommendations](#), which could boost energy policy with fresh investment.

Also, a new [observatory](#) is set up to share data, knowledge and best practices on energy poverty in the EU.

World's biggest city database shines light on increasingly urbanised planet

The Joint Research Centre, the European Commission's science and knowledge service, launched a new [tool](#) with data on all 10,000 urban centres scattered across the globe.

The [city centres database](#) shows growth in population and built-up areas over the past 40 years and tracks environmental factors.

The data is free to access and open to everyone.
